

**New Hampshire State Law: N.H. Revised Statutes § 154:8c**

Section 154:8c of the New Hampshire Revised Statutes (the “New Hampshire Law”) requires a manufacturer or other person that sells firefighting personal protective equipment (PPE) to provide written notice to the purchaser whether or not the firefighting PPE contains PFAS chemicals.

The New Hampshire Law defines firefighting PPE as “any clothing designed, intended, or marketed to be worn by firefighting personnel in the performance of their duties, designed with the intent for use in fire and rescue activities, including jackets, pants, shoes, gloves, helmets, hoods and respiratory equipment.”

Honeywell Safety Products is providing the following information regarding Honeywell First Responder Products (HFRP) firefighting PPE in compliance with the New Hampshire Law.

Based on information provided by our suppliers, PFAS chemicals are contained in certain technical fabric products that are component parts of the HFRP products listed in Annex A.

Under the New Hampshire Law, the seller and the purchaser of the firefighting PPE must retain the written notice in procurement files for at least three years from the date of the transaction. Upon request of the New Hampshire Department of Safety, the seller or the purchaser must furnish to it the notice and associated sales documentation within 60 days.

The written notice shall be included in all personnel files of all employees using the firefighting PPE.

This memorandum shall serve as Honeywell Safety Products’ written notice for purposes of complying with the New Hampshire Law.
