

#### Washington State Law: Rev. Code Wash. § 70A.400.030

Section 70A.400.030 of the Revised Code of Washington (the "Washington Law") requires a manufacturer or other person that sells firefighting personal protective equipment (PPE) to provide written notice to the purchaser at the time of sale if the firefighting PPE contains PFAS chemicals.

Washington law defines firefighting PPE as "any clothing designed, intended, or marketed to be worn by firefighting personnel in the performance of their duties, designed with the intent for the use in fire and rescue activities, including jackets, pants, shoes, gloves, helmets, and respiratory equipment."

Honeywell Safety Products is providing the following information regarding Honeywell First Responder Products (HFRP) firefighting PPE in compliance with the Washington Law.

Based on the information provided by our suppliers, PFAS chemicals are contained in certain component parts used in the HFRP products listed in Annex A. These component parts are technical fabrics that use PFAS chemicals to provide water repellency and to meet performance standards for firefighter PPE.

Under the Washington Law, the seller and the purchaser of the firefighting PPE must retain the written notice for at least three years from the date of the transaction. Upon the request of the Washington Department of Ecology, the seller or purchaser must furnish the notice, or written copies, and associated sales documentation to it within 60 days.

This memorandum shall serve as Honeywell Safety Products' written notice for purposes of complying with the Washington Law.
