

California State Law: California Health & Safety Code § 13029.

Section 13209 of the California Health & Safety Code (the “California Law”) requires any manufacturer or other person that sells firefighter personal protective equipment (PPE) to provide written notice to the purchaser at the time of sale if the firefighter PPE contains intentionally added PFAS chemicals.

The California Law defines “firefighter personal protective equipment” as personal protective equipment covered by the general industry safety orders in §§ 3403 to 3411, inclusive, of Title 8 of the California Code of Regulations. As so defined, the written notice requirement applies to sales of the following if worn by fire fighters when exposed to the hazards of firefighting activity: helmets, self-contained breathing apparatuses, eye protection, hoods or shrouds, garments, gloves, foot protection, and personal safety alert systems.

PIP-HSP is providing the following information regarding Morning Pride (MP) Responder Products firefighter PPE in compliance with the California Law.

Based on information provided by our suppliers, PFAS chemicals are contained in certain component parts of the HP products listed in Annex A. These component parts are technical fabrics that use PFAS chemicals to provide water repellency and to meet performance standards for firefighter PPE.

Under the California Law, the seller and the purchaser of the firefighter PPE must retain a copy of the written notice for at least three years from the date of the transaction. Within 60 days of a request by the Attorney General, a city attorney, a county counsel, or a district attorney, the seller or purchaser must furnish to the requesting entity the written notice, or a copy of the written notice, and associated sales documentation.

This memorandum shall serve as Morning Pride Manufacturing LLC’s written notice for purposes of complying with the California Law.
