

NOTICE: THIS PRODUCT CONTAINS ADDED PFAS

Massachusetts State Law: ALM GL ch.111 §245

Chapter 111 of the Massachusetts State Law requires a manufacturer or other person that sells firefighting personal protective equipment (PPE) to provide written notice to the purchaser at the time of sale if the firefighting PPE contains intentionally added PFAS chemicals.

Massachusetts law defines firefighting PPE as “any clothing, including jackets, pants, shoes, gloves, helmets, and respiratory equipment, designed, intended, or marketed to be worn by firefighting personnel in the performance of their duties.”

In compliance with the Massachusetts Law, PIP-HSP provides the following information regarding Morning Pride (MP) First Responder Products firefighting PPE.

Based on information provided by our suppliers, PIP-HSP understands that certain component parts of the Morning Pride products listed in Annex A contain intentionally added PFAS chemicals. Information on which components contain PFAS and the specific PFAS contained in those products can be found in Annex A. These component parts are technical fabrics that use PFAS chemicals to provide water repellency and to meet performance standards for firefighting PPE under NFPA requirements.

Under the Massachusetts Law, the seller and the purchaser of the firefighting PPE must retain the written notice for at least three years from the date of sale.

This memorandum shall serve as Morning Pride Manufacturing LLC Products’ written notice for purposes of complying with the Massachusetts Law.
